## LOCATION

The UpperDeck enjoys an enviable trading location in Falmouth Marina, providing a virtually unopposed restaurant business. The marina provides an immediate captive audience in addition to the normal day-to-day trade.

Falmouth is one of the UK's most popular harbour resorts attracting large numbers of tourists throughout the year due to its beautiful harbour, coastline, beaches and the National Maritime Museum.

## DESCRIPTION

This outstanding licensed restaurant and bar offers approaching 2,000 sq ft of restaurant/ function space enjoying a stunning marina vista.

Briefly, the accommodation comprises reception hall with access to customer cloakrooms; main restaurant area with a well-equipped bar servery; a further restaurant area/function room; outside seating to the front and rear providing circa 30 covers with views over the marina and estuary beyond; equipped commercial kitchen; store room with office area, and cellar.

## THE BUSINESS

The UpperDeck licensed restaurant trades daily from 11.30am to 10.30pm, with food being served 12pm to 3pm and 5pm to 9pm. In addition to the main restaurant and bar trade, the business also provides occasional live music and also offers an excellent environment for private functions.

For year end October 2024, the business generated gross sales approaching £500,000 for the twelve month period. Further accounting information will be made available to seriously interested parties following a viewing appointment.

## FIXTURES & FITTINGS

Normal fixtures and fittings associated with this type of property are included in the sale and detailed inventory of trade fixtures and fittings will be supplied prior to exchange of contracts.

## EPC

The premises has an EPC Rating of B under Certificate Reference Number 9838-3023-0433-0205-0695.

## LICENCE

The property has the benefit of a Premises Licence issued from Cornwall Council. (It is a requirement under the Licensing Act 2003 that the properties serving alcohol have a dedicated premises supervisor who must be the holder of a Personal Licence. Any prospective purchaser is advised to take appropriate specialist advice.)

## BUSINESS RATES

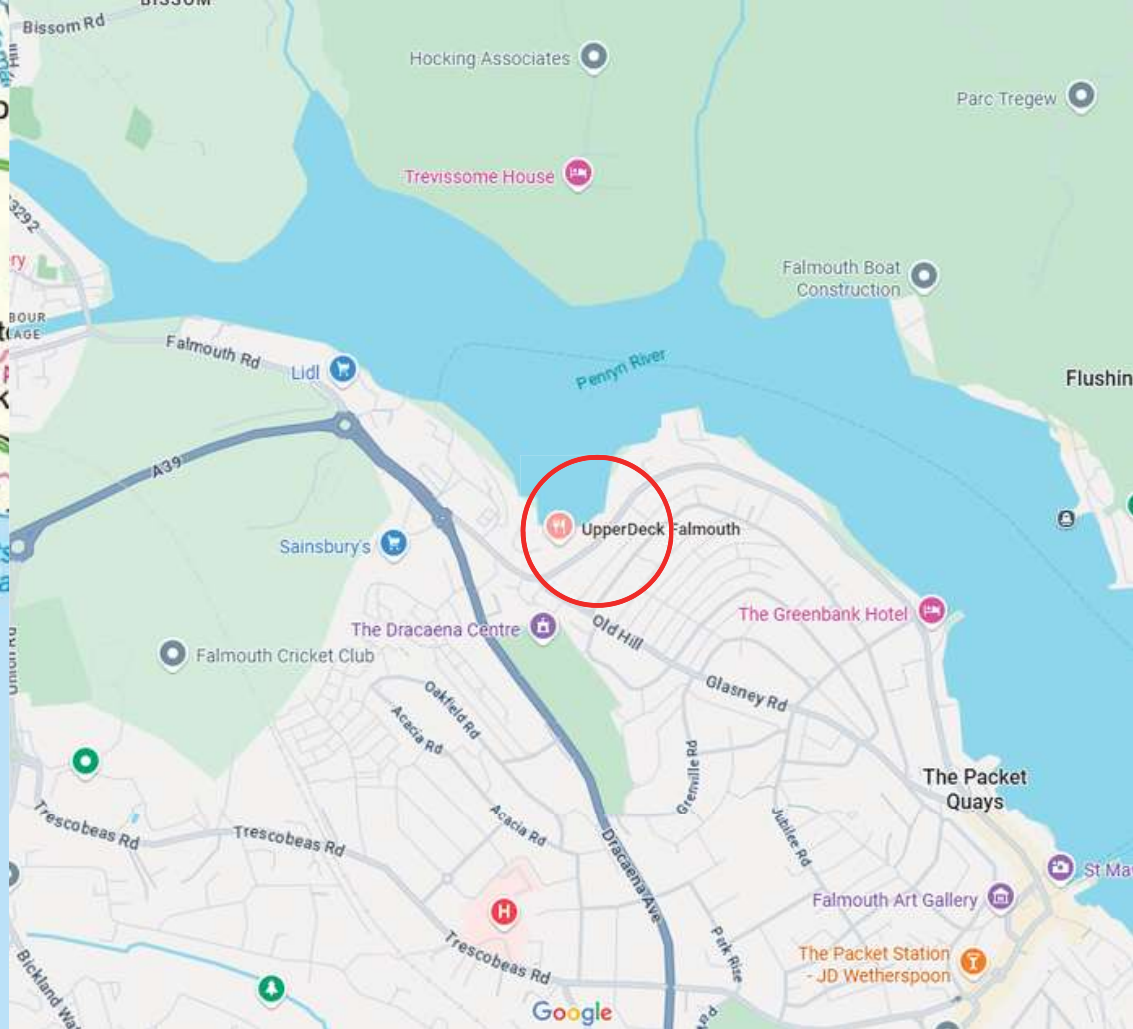
