Within walking distance of the property there is a free car park on the junction of Brookside and Chapel Street.



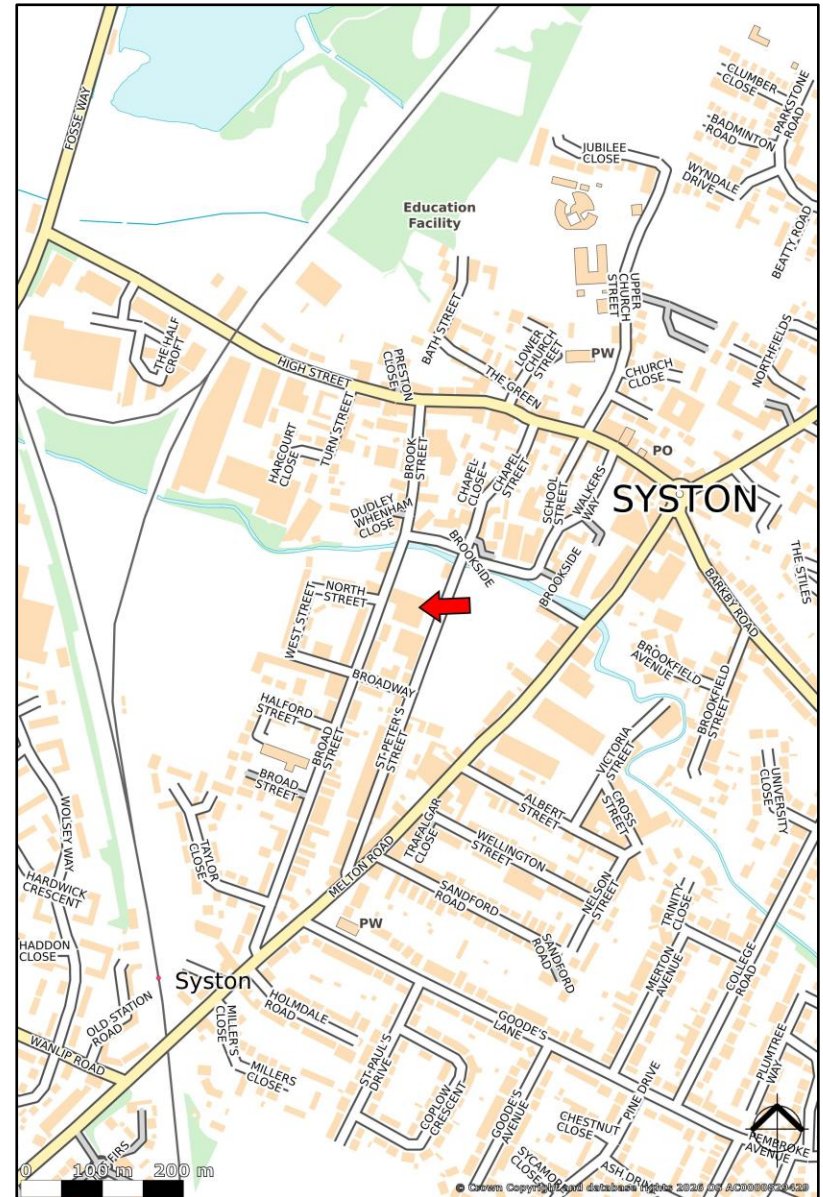
