LOCATION

The Wharfside Centre is Penzance’s premier commercial and retail centre, linking the town’s traditional Market Jew Street with the council owned principal visitor\shoppers 800 space car park, the bus and train stations. The Scilly Isles Ferry Terminal and the Scilly Isles Heliport are also located within a short walk of the property.

Occupiers within the scheme include Card Factory, Warrens Bakery, Iceland and a good number of independent traders and service providers. The town has a resident population of circa 20,000 with a catchment of 180,000 persons within a 30 minute drive (StorePointGeo). These numbers swell substantially due to the large number of tourist visitors attracted to the area throughout the year and particularly in the summer months.

A 61 room Premier Inn is located less than a minutes walk to the north, with a Churchill development of 50 luxury one and two bed apartments is located immediately to the south.

Wharfside is the home to 31 flats, with consent for a further 40 flats in the near future.

The focus of the town centre, Wharfside offers modern retail units with convenient access to the main town centre car parks via lifts, escalators and stairs with unrivalled views across Mounts Bay to St Michael’s Mount.

The commercial accommodation is arranged with frontages onto Market Jew Street, Wharf Road and into the mall. Each unit is of modern construction and is presented in a shell condition ready for tenant fit-out, with WC and glazed shopfronts already installed. The retail units are served by a purpose built service and loading yard.

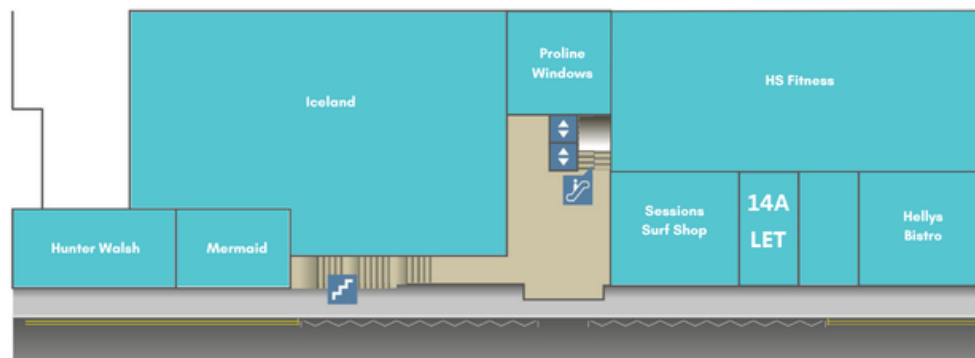
1st Floor

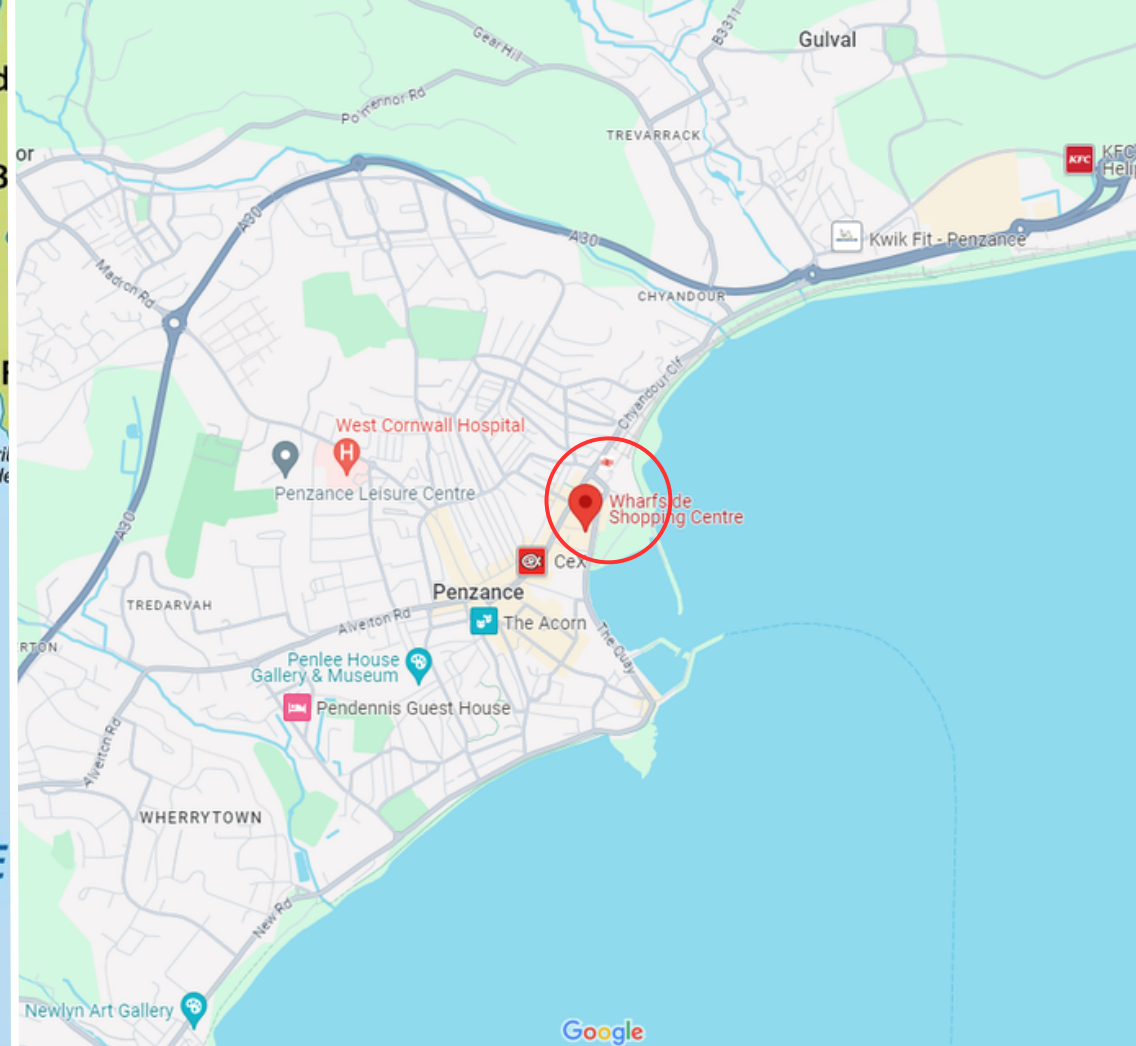
